#### FORMAT FOR SUBMISSION OF MEMORANDUM TO 2<sup>nd</sup> MIZORAM FINANCE COMMISSION IN RESPECT OF DISASTER MANAGEMENT & REHABILITATION DEPARTMENT

- 1. Paragraph 4(vi) of the Terms of Reference of the 2<sup>nd</sup> Mizoram Finance Commission prescribed that "In making its recommendations, the Commission shall have regard, among other considerations, to the need to enhance disaster management at the local levels so as to avoid minor disasters such as landslips, etc. at the local levels". Kindly provide a note on the views/comments of the State Government in Disaster Management and Rehabilitation Department in the form of a memorandum with special reference to the provisions in the Terms of Reference mentioned above with a view to facilitate the Commission make an effective recommendation to enable the local bodies discharge their functions pertaining to disaster management efficiently.
- 2. Kindly elaborate the role of Village Councils in the various stages of disaster management viz. prevention, mitigation, preparedness, response, restoration and rehabilitation reconstruction work.
- 3. Suggest measures for making Village Councils as the nodal agency for relief and rehabilitation at the village level. The 15<sup>th</sup> Finance Commission has, in fact, stated that making panchayats the nodal agency for relief and rehabilitation will result in improved planning, coordination and monitoring (Para 8.105 of XVFC Report)
- 4. Kindly elaborate the role of Local Councils within the limits of Aizawl Municipal Corporation in the various stages of disaster management viz. prevention, mitigation, preparedness, response, restoration and rehabilitation reconstruction work.
- 5. Suggest measures for making Local Councils as the nodal agency for relief and rehabilitation at the local level. The 15<sup>th</sup> Finance Commission has, in fact, stated that making panchayats the nodal agency for relief and rehabilitation will result in improved planning, coordination and monitoring (Para 8.105 of XVFC Report)
- 6. Kindly elaborate the role of Autonomous District Councils in the various stages of disaster management viz. prevention, mitigation, preparedness, response, restoration and rehabilitation reconstruction work.

- 7. Kindly elaborate the role, if any, of Aizawl Municipal Corporation in the various stages of disaster management viz. prevention, mitigation, preparedness, response, restoration and rehabilitation reconstruction work.
- 8. The subject matter of "Creation of corpus fund in each of the three Autonomous District Councils for rendering assistance to victims of natural calamities and for proper implementation of the Central Act on disaster management" is one among the several functions of the State Department that are entrusted by the Governor to the three Autonomous District Councils vide Notification No.C.13016/3/2010-DCA dt 29.08.2011 published in the Mizoram Gazette extra ordinary issue No. 388 dt 01.09.2011. Kindly elaborate the steps taken by the State Government towards implementation of the above function transfer to the three ADCs.
- 9. Please provide brief note on the existing procedure and principles, if any, for distribution of resources from the State Disaster Response Fund (SDRF) and State Disaster Mitigation Fund (SDMF) to the District Disaster Management Authorities/District Administrations.
- 10. Whether or not the State Government has evolved any specific methodology for allocating resources from the State Disaster Response Fund (SDRF) and State Disaster Mitigation Fund (SDMF) to the District Disaster Management Authorities/District Administrations as per the recommendation of the 15<sup>th</sup> Finance Commission (Para 8.101 of XVFC Report). If not, steps taken to prepare methodology for distribution of resources may be given.
- 11.Kindly provide the distribution of resources from the State Disaster Response Fund (SDRF) and State Disaster Mitigation Fund (SDMF) to the District Disaster Management Authorities/District Administrations as per the format prescribed in the Schedules appended.
